

WARRANTY



NOW, THEREFORE, Manufacturer hereby warrants, to the above Owner (subject to the following terms and conditions) the booster system, as follows:

- against defect in workmanship, materials and equipment installed as part of the system package for a period of one (1) year from the date of factory start-up report (in any event not to exceed eighteen (18) months from the date of shipment);
- the variable frequency drives shall carry a two (2) year parts and labor warranty from the start-up date (not to exceed thirty (30) months from the date of delivery).
- Manufacturer shall repair or replace, in its sole determination, all defective parts, and/or correct any defects in workmanship or materials, at no cost to the Owner.
- Manufacturer shall provide 24 hour / 7 days a week "on site" field factory warranty service, except as provided in the "Exclusions from Coverage" paragraph below.

Exclusions from Coverage

- Damages caused by improper lifting, rigging or handling of the equipment;
- Any damages due to misuse, neglect or service by other than qualified manufacturer trained personnel during the term of this warranty, (except emergency cases and then only under the direction of the Manufacturer)
- Damages caused by flooding, windstorms, lightening strikes, fire, wars or any acts of God
- Any and all damages caused by or resulting from the booster system, including, without limitation any incidental or consequential damages
- Any and all damages caused by use of the equipment for any application other than as designated by the Manufacturer; and Any and all travel (to and from) and lodging (if needed).

Maintenance Condition

- As a condition of this Warranty, the Owner must maintain the product subject to the warranty. Failure to comply with these requirements shall void this Warranty.

Unapproved Repairs, Alterations and Additions to Void Warranty

- In the event that the Owner, without having first obtained the written consent of Manufacturer, shall hereafter make or permit any repairs, alterations or additions to the Equipment, or change the use, function or purpose of the Equipment, this Warranty shall immediately become void.

Examination Not To Constitute Waiver

- Neither the issuance of this Warranty nor any review or inspection of the Equipment by the Manufacturer representatives shall constitute waiver by the Manufacturer of the exclusions or limitations of this Warranty, nor may any representative of the Manufacturer waive any of the exclusions or limitations of this Warranty either orally or in writing.
